The 25th Meeting of the State Level Programme Management Committee (SLPMC) of OTELP was conducted under the Chairmanship of Sri Surendra Kumar, IAS, Commissioner-Cum-Secretary, ST & SC Development, Minorities and Backward Classes Welfare Department and Chairperson, OTELP, in the Conference hall of PSU, OTELP, Bhubaneswar on 18.01.2016 at 3.30PM. Agenda item No.6: Continuation of OTELP staff after 31.03.2016 to prepare the Project Completion Report.

The last date for expenditure of IFAD Loan by OTELP is 31.03.2016 & Project closing date is 30.09.2016.

The different major tasks to be attended to after 31.03.2016 were discussed vividly. It was decided to formulate a proposal within one week with sufficient justification for referring the matter to Finance Department for a decision. The FA of the Department, who was

present in the meeting was advised to take up the matter with FD for a decision by the end of January, 2016. It was also decided to put up a UOI Note to ACS, Finance to convey Inter Departmental Meeting.

Agenda item No.7: Creation of PSU to implement OTELP Plus and continuation of OTELP Phase-I & II

The PSU OTELP is looking after OTELP Plus & OTELP Phase-I continuation as State Unit. Keeping in view the closure of OTELP on 31.03.2016, the MOUs of FNGOs and the engagement of staff of PSu & ITDA have been renewed up to 31.03.2016.

The implementation of OTLEP Plus and Continuation in Phase-I & II areas were discussed in detail. The necessity of a PSU at the State Level was felt by the Committee. The Programme Director, OTELP presented the submission of proposal of Rs. 13.96 Crore in the budget for 2016-17 to implement OTELP Phase-II Continuation, which includes remuneration of PSU, ITDA staff and FNGOs.

Since no post has been sanctioned yet, communication has been made by PSU again vide $_{*}$ letter no 136 dt. 14.01.2016 to Dept. for sanction of the posts.

It was decided that Finance Department shall be moved for sanction of posts as requested by the Programme Director. The PSU of OTELP shall be converted to the PSU, OTELP Plus by Govt. which will also look after the activities of Phase-I and Phase-II Continuation.

Agenda item No.8: Engagement of FNGOs in OTELP Plus

It was decided to entrust to Xavier Institute of Management, Bhubaneswarthe task of preparing a list of eligible of FNGOs in order to merit for their selection as there is no Procurement Expert in the PSU. The selection of FNGO has to be done in a very open and transparent manner.

The meeting ended with a vote of thanks to the Chair and all the participants.
